

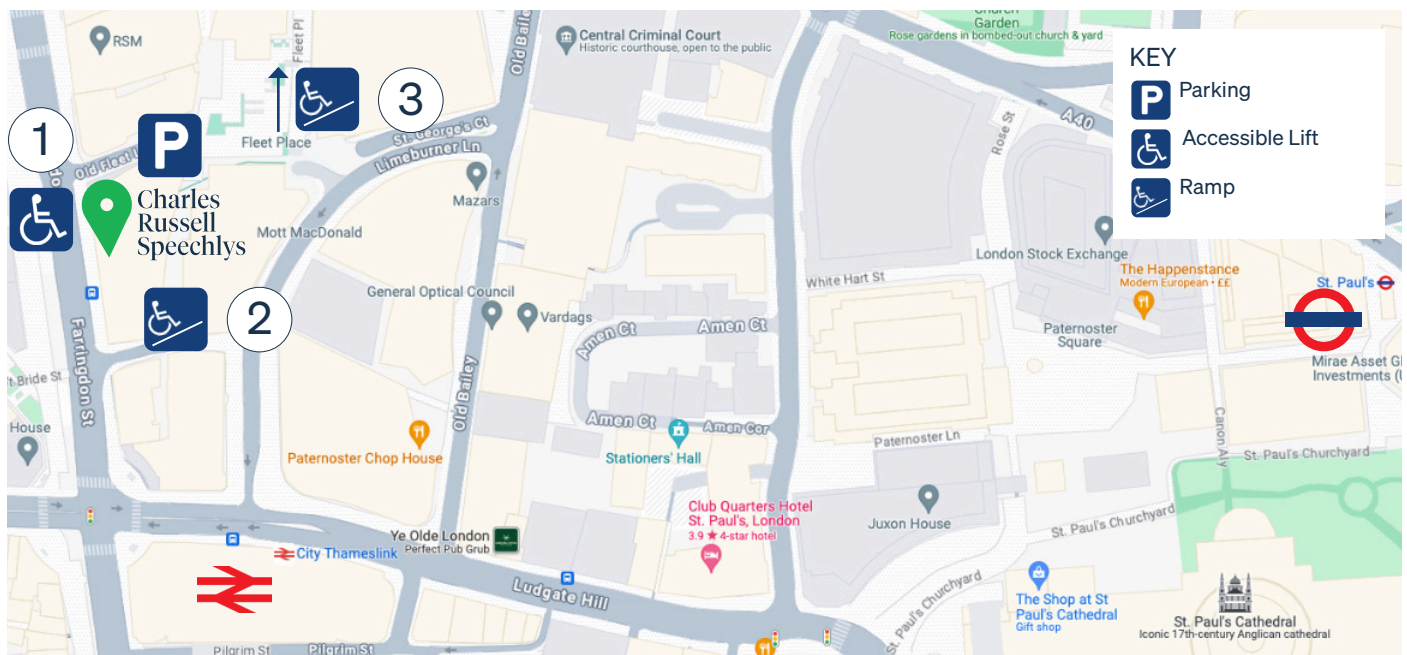

There is a public lift on Farringdon Street next to the steps that lead up to 5 Fleet Place. There is also a ramp that leads to Fleet Place via Limeburner Lane directly opposite the restaurant Obica. There are limited parking facilities subject to availability, detailed below.

Charles Russell Speechlys is situated on Levels 0, 4 – 9 in 5 Fleet Place. All visitors will need to check in with Ground Floor Reception on arrival then make their way to Level 7 where the Reception team will contact your host. For security purposes, please ensure you sign in and carry your pass.

There are several train stations situated locally, we would advise that you access their website to find out their detailed accessibility information.



Public lift to Fleet Place, accessible lift via Farringdon Street – located on the left of the stairs.

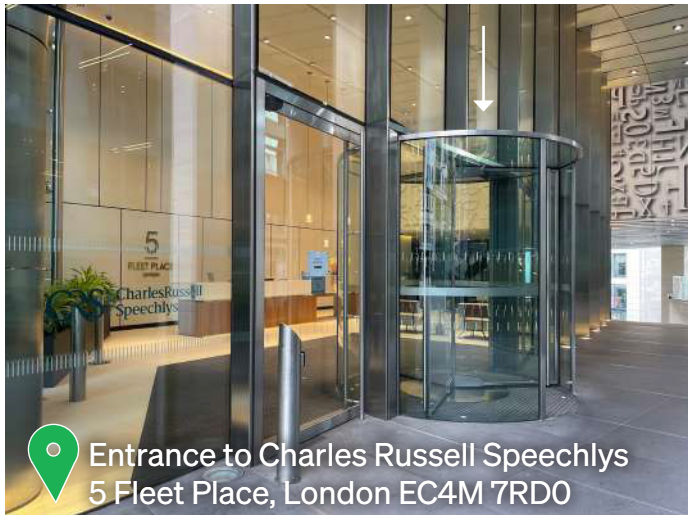


Step free access via Limeburner Lane – please turn left at the end of the ramp to access 5 Fleet Place.

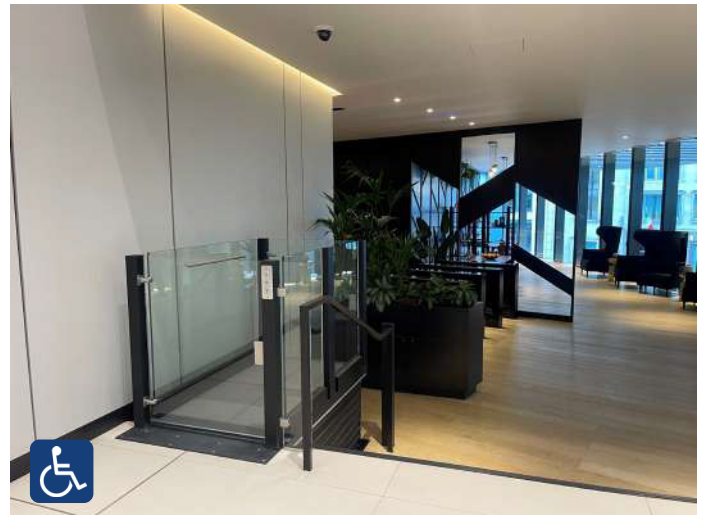


Step free access via Fleet Place – if you are arriving by  City Thameslink (North Entrance).
